I can attest to this as someone who hustled for authors to fill the Briefing the Case column from 1989 to 1992. Unfortunately SWALL Bulletin gradually went into a hiatus in recent years.

SWALL Business Meeting Minutes

July 24, 2011

Philadelphia, PA, AALL Annual Meeting

Meeting called to order by President Mon Yin Lung at 5:35p.m.on Sunday, July 24, 2011 in Marriot room 302-304 in Philadelphia, Pennsylvania.

A moment of silence was observed in the memory of Lori Bull Dodds and she was remembered for her contributions to SWALL and the profession.

Annual Meeting Status Report: Mon Yin Lung

- The 2011 annual meeting was deferred to the fall for a joint MAALL-SWALL meeting.
- In addition, a joint meeting between HALL and SWALL was hosted by the University of Houston on March 11th and 12th. The program was very successful, with 3 CLE credits offered.

2011 MAALL-SWALL Joint Meeting: Mon Yin Lung

- The meeting will take place in Lawrence, Kansas, November 3rd through 5th.
- More than 24 proposals for three tracks of programming were received.
- More information about the meeting and registration is coming soon. The Joint Meeting Local Arrangement will set up a website.

Chapter President Report: Mon Yin Lung

- Mon Yin Lung attended the Council of Chapters Business Meeting. The President of the Chapter Council president stated that the AALL Executive Board requested the chapters to post on their website a message that chapter members should not use the chapter discussion lists to transfer files downloaded from database or commit any action violating copyright law.
- There was additional discussion among the chapter presidents on the AALL Executive Board's other request for no discussion on vendor pricing, although this request was postponed for the time being.

- The President of the Chapter Council also forwarded another request from the AALL Executive Board: that since candidates running for AALL Executive Board are not allowed to campaign for the position, chapter members should not bring up the candidacy in the discussion list. This statement drew some lengthy discussion. The Council President will bring it back to the AALL Executive Board for further discussion.

Treasurer Report: Treasurer Jennifer Laws was not present; President Mon Yin Lung reported in her absence that SWALL's assets were around \$15,000.

- Constitution and By-laws Committee: No report.
- Finance Committee: No report.
- Grants Committee: David Gay
David Gay introduced Katy Stein from St. Mary's University Law Library and Faye Hadley from the Mabee Legal Information Center at the University of Tulsa College of Law as the 2011 AALL annual meeting grant recipients. There are plans to offer three grants for the MAALL-SWALL joint meeting. Additional grants are planned for the 2012 meeting in San Antonio, details to be announced later.
- Legal Information Services to the Public: Mike Martinez was appointed as the new committee chair.
- Lifetime Memberships and Memorials: Mon Yin Lung made announcements for Sharon Wayland and Rick Ducey that Sharon Blackburn will be nominated for a lifelong membership and a memorial will be made for Lori Bull Dodds.
- Local Arrangements Committee: Katy Stein reported that the 2012 SWALL Annual Meeting will take place from March 28 to March 31 at the historic Menger Hotel in San Antonio. Arrangements are currently being made with more information to be available soon.
- Membership Committee: Mon Yin Lung commented that from 2003 to 2010 membership in SWALL declined from 281 members to 179. The goal for the future is to recruit and retain members.
- Private Law Libraries Committee: Riva Laughlin is the new committee chair. SWALL will be making an increased effort to recruit private law librarians.
- Program Committee: Program committee chair Bob Hu was not present. Mon Yin Lung announced program committee members.

- Publications Committee:
Elizabeth Caulfield is the chair. Committee members include Richard Guajardo, Emily Lawson, and Lauren Schroeder. Emily Lawson and Lauren Schroeder also serve as the SWALL web mistresses. Consideration was made to restart SWALL Bulletin on the SWALL website. Jessica Alexander suggested developing a social network presence for SWALL. RSS feed will be added to the front page.
- Public Relations Committee: No report.

Meeting adjourned at 6:25p.m., attendees were welcomed to the reception that followed.

AALL's Continuing Professional Education Committee presents the AALL2go pick of the month: [Overcoming the Challenge of Change](#).



This one-hour, 43-minute audio file (mp3) was recorded at the 2011 Northern California Association of Law Libraries Spring Institute and features **Sandra Yancey**, founder and CEO of eWomenNetwork. Through frank discussion of real-life issues, this program will help librarians understand how to personally become an effective "change agent" and overcome obstacles associated with change.

Yancy begins by discussing her own personal journey into business ownership. She then walks audience members through a series of exercises and then discusses the results. She also discusses why little changes went unnoticed and why certain changes happened. Many of these tools and concepts that were incorporated into the session were created by Joel Barker, William Bridges, and Stephen Covey. Through this series of exercises followed by discussion, Yancy provides the audience with a framework whereby they can work with their own staffs to understand the challenges of change in any organization. SWALL Grant Recipient: 2011 AALL Annual Meeting Report

The 103rd AALL Annual Meeting in Philadelphia, Pennsylvania, which took place from July 23rd to July 26th, was among the most exciting and informative meetings I've had the pleasure of attending. Our host city, Philadelphia, provided a wonderfully historic backdrop and served as a reminder of the rich history of American law and the importance of law librarians in its preservation and continued evolution. After arriving on Saturday afternoon, I was met with heat rivaling that of my home city, San Antonio, which made me feel quite at home. The first event I attended after checking into my hotel was the exhibit hall ribbon cutting and opening reception, where I enjoyed both the delicious pretzels and visiting with colleagues from around the country.

The meeting's programming began in earnest on Sunday morning with the opening general session and address by this year's keynote speaker, Dahlia Lithwick. A writer for Slate.com, she addressed how privacy concerns may be creating new divisions among the Supreme Court justices. Interestingly, she theorized that Justices Thomas and Alito may have more guarded views on privacy rights after their own difficult confirmation hearings. Ms. Lithwick's address connected many issues important to law librarians, from first amendment limits to access to the courts, and provided much food for thought. Following the opening session and address, I attended a lunch held by the Latino Caucus, where Yolanda Vazquez, a law professor at the University of Pennsylvania spoke to the group. Ms. Vazquez addressed the problems and consequences of incorporating immigration law into the criminal justice system, an important topic especially for those who often work with pro-se patrons.

Of the programs I attended at the annual meeting, several stood out for both their quality and ability to enhance the work that I and other librarians do at St. Mary's University Law Library. The first of these, "Best Practices for Evaluating a New Electronic Resource," addressed best practices for librarians when evaluating whether or not to purchase a new electronic resource. Best of all, the program included a sample evaluation checklist for librarians to use when making

decisions about these resources, a handout that I think we will modify and use here at St. Mary's for our collection development decisions. The checklist includes areas for decision makers to evaluate a resource considering many factors, including: cost, content, search features, technical support, and catalog record availability. Another interesting program, "Peeping THOMAS: A Little Look at a Big System," introduced the audience to the librarians and technical professionals who maintain and improve Thomas.gov, a resource I both use and teach often. Though most of the program focused on changes the team had made based on user feedback, it definitely made me excited about new developments in THOMAS that will be coming in the next year.

Other programs and components of the meeting also helped me enhance my professional knowledge and skills. As the faculty services librarian at St. Mary's, the annual faculty services roundtable has consistently been a highlight for me. This year, there was spirited discussion about how much current awareness information can and should be provided to law professors, based on their degree of interest. I heard lots of interesting ideas from other schools, like personalized current awareness newsletters, some of which I hope to implement in the coming school year. Another program that was of great interest to me was Tuesday's program, "The New Generation of Legal Research Databases: Eighteen Months Later." This program surveyed librarians from courts, law firms, and law schools about their adoption and use of WestlawNext. Though many librarians seem to have mixed feelings about the products, it was helpful to hear about the experiences of users from outside the academic context, as it will better inform my teaching.

In addition to the many great programs, I was also fortunate to spend some time at the exhibit hall, where I was able to see new vendor products, and connect directly with the vendors our library uses and express any questions or concerns. Though I did not win an iPad, or the car offered by Hein, I did receive plenty of product information and ideas to bring home with me. Another highlight of the conference was attending the SWALL business meeting and reception, where I was able to meet many SWALL librarians I had yet to meet in person, or at all. Strengthening these community relationships is certainly one of the most rewarding aspects of attending the annual meeting.

Though the activities of the conference did not leave me much time for sightseeing, I was able to explore a little bit of Philadelphia, and of course visit the Liberty Bell and Constitution Hall. Spending time eating meals and chatting with colleagues I do not often have a chance to see in person was also wonderful, and was enhanced by all the delicious food Philadelphia had to offer. I was impressed by Philadelphia's sense of history in such a bustling city, and hope to return someday soon. I very much enjoyed my conference experience at the AALL Annual Meeting in Philadelphia, and I am most grateful to SWALL for awarding me a grant to help me to attend. I encourage other SWALL members to apply for annual meeting grants next year, and hope to meet many more SWALL members at our upcoming meetings and conferences.

In Memoriam: A Tribute to Lori Bull Dodds

Lori Bull Dodds first introduced herself to me through an e-mail directed to all North Texas County Law Librarians. Having been introduced to the world of law librarianship only a few months prior to her e-mail, I was ecstatic. Finally, someone was reaching out to me with a warm and welcoming gesture. That was in the spring of 2008.

The welcome she gave several of us as we met in the Collin County Law Library was just as I had hoped it would be....warm and welcoming. Every time after that was similar. Lori was non-judgmental, open, gracious, and generous with both her time and her knowledge. There were many times when I called her with a question or request to e-mail me a form....she was always spot-on there for me.

Soon she and Virginia Eldridge from Grayson County and I were taking little road trips to other libraries in our area. We met at Grayson County Law Library, then my own Denton County Law Library, Tarrant County Law Library, and on our last trip together, we met with Wichita Falls County Law Librarian, Sherry Jones. Lori had arranged this trip with Sherry who was grateful for the connections. I believe it was this trip and our conversations with Sherry that led Lori to ideate a new committee for SWALL – the Special County Court Law Library Committee.

As a member of SWALL, I was put on the Program Committee for our conference in Waco. I felt totally inadequate to serve, so I summoned Lori's and Virginia's help in brain-storming for some program ideas. We met in Denton and each of them produced more than their share of ideas....most of which were accepted not only by the Program Committee and the President, Michelle Rigual, but especially by the attendees at the Conference. Little by little, with Lori's and Virginia's support, I was learning law librarianship and increasing my confidence.

Even now, I have tears in my eyes...Lori and I were becoming friends. She was someone I could relate to and be myself with, never fearing that she would criticize but gently guide me, if I were misdirected. Her unexpected absence has left a deep hole in my heart as I was looking forward to spending more time with her. We did share a long walk along the Brazos River at the SWALL meeting in Waco. Those moments are golden in my memory, as is Lori. The only consolation is that she was as close to the heavens as one can be on this earth....she had only a few steps to take to be totally spiritual....for she was already close to that here on earth.
